**Content (Syllabus outline):**

- Written and oral reflection and debate based on the particular cases of participation and help.
- Active involvement in concrete projects and initiatives of active citizenship, e.g. performing student assignments within the faculty, developing own initiatives and providing other relevant forms of help in the community in agreement with the lecturer.
- The significance of internationalisation in education, including the participation at the relevant lectures of the visiting professors and or participation in the student exchange.
